Upon suggestion of the City Administrator and in thought of upcoming town events, the dates of April 7 and 8 were selected with the option of rescheduling pending threatening weather. Council Member Dunn motioned to approve and was seconded by Smith. **Motion Carried 3-0**

Item #4. Discuss and consider a City Database Maintenance Agreement with East Texas Council of Governments. City Secretary reviewed benefits, initial costs and ongoing costs with the council. Council chose to table this discussion for further review during Budget Workshops.

Item #5. Discuss and consider renaming Ordinances Chapter 5 from the current "Billiard and Pool Establishments" to be more inclusive of all business types with a new title of "General Business Regulations." The administrator discussed that the Chapter is too specific and only contains one ordinance. Council member Pendleton motioned to approve changing the name of Ordinances – Chapter 5 to "General Business Regulations" and the motion was seconded by Dunn.

Item #6. Consider and approve mulch samples and cost for the City Park Playground. 4 samples of mulch were provided by Council member Dunn and shown to council. After hands on review, costs and durability were examined, council member Smith made a motion to approve the Fresh Hardwood Mulch Sample and was seconded by Dunn.
