New Business:

Executive Session: The City Council reserves the right to meet in closed session in accordance with Texas Government Code, Subchapter 3, Section 551.072 Deliberations Regarding Real Property.

1. Discuss and consider the current contract for the purchase of the Edgewood Senior/Civic Center. Chef Elle updated council that the local bank has denied financing due to being a restaurant. She has asked for an extension to start securing financing from her personal bank. Chef Elle's original earnest check of \$4,800 was dishonored. She presented council with a \$1,000 money order.

The original existing slab hangs over into this requested easement due to the property being located partly in a flood zone. The easement will allow entire office to be constructed in a safe zone and still leave parking and unobstructed roadway. Dunn motioned to deed 15' of the city easement starting at the eastern property line of 301 W Pine St towards S. Lamar Street. Goggans seconded the motion.
