

**Ordinance 081224**

**AN ORDINANCE OF THE CITY OF EDGEWOOD, TEXAS, CODE OF ORDINANCES, APPENDIX A, EDGEWOOD, TEXAS FEE SCHEDULE REVISING CERTAIN FEES OF WATER, SEWER, UTILITY BILLING PROCEDURES, WATER TAP RATES, SANITATION CHARGES, BUILDING PERMIT FEES, UTILITY PERMIT FEES, MISCELLANEOUS FEES AND BUSINESS FEES TO ALL COMMERCIAL AND RESIDENTIAL CUSTOMERS IN THE CITY.**

**WHEREAS**, pursuant to Texas Local Government Code section 51.001, the City Council may adopt an ordinance, rule or regulation that is for the good government or the trade and commerce of the City.

**WHEREAS**, the City has determined that it is necessary and in the best interest of the City and residents to amend the fee schedule containing fees charged by the City for water, wastewater and sanitation services. The collected revenues will cover all costs for debt service, for current capital improvements, and for operation and maintenance of a publicly owned waterworks and City services.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF EDGEWOOD, TEXAS:**

**SECTION 26-2. (a)** The City hereby expressly retains the exclusive original jurisdiction over the rates, operations and services within the existing and future incorporated limits of the City.

**SECTION 26-2. (b)** The following fees shown attached as Appendix A shall be implemented by the City of Edgewood, Texas Code of Ordinances and placed in Part II Land Development- Appendix A of the City Code of Ordinances. The fee schedules will be fully accessible to the general public to be maintained by the City Secretary at the City office.

APPENDIX A – Edgewood, Texas Fee Schedule

**SECTION 15.2.03** All provisions of the ordinances of the City of Edgewood, Texas in conflict with the provisions of this Ordinance, except as noted herein, be, and the same are hereby repealed, and all other provisions not in conflict with the provisions of this Ordinance shall remain in full force and effect.

**SECTION 15.2.04** Should any word, phrase, paragraph or section of this Ordinance be held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this Ordinance as a whole, or any part or provision thereof other than the part so decided to be unconstitutional, illegal or invalid, and shall not affect the validity of the Ordinance as a whole.

**SECTION 15.2.05** The fees contained in this ordinance shall take effect October 1, 2024, from and after the ordinance passage, and it is adopted.

**Utility Billing Procedure:**

Water Deposit - \$200.00

\$20.00 Late Charge will automatically be added on the 10<sup>th</sup> of each month.

Reconnect fee of \$50.00 will be charged for nonpayment of water service in addition to payment of account in full to activate water service.

Meter tampering fee of \$50.00 will be added to utility bill (at time of discovery by City) and meter will be pulled at that time at the discretion of the City. There will be an additional \$150.00 payment due prior to reinstallation of water meter.

Where street pavement, sidewalk or any areas paved with concrete or asphalt materials are cut and replaced with asphalt to install a water or sewer line/tap an additional cost will be charged.

**Boring Installation Fees:**

When it necessary to bore under streets or sidewalks for water or sewer service line installation, all costs will be incurred by the customer.

**Availability Fee:**

Locate an existing water meter/tap or sewer tap \$100.00/hour.

**Damage to Utility Lines:** Actual expense to City with \$1,500 minimum fee.
