### **Consent Agenda:**

Upon a motion made by council members Smith and Dunn, the council voted to approve the Consent Agenda consisting of the February 10, 2025 City Council minutes, February 27, 2025 Special Meeting minutes and paying of the expenses.

1. Consider and approve the replating of property R000009104 (1.231 acres) located on Boone St in the T.J. Shaw Survey, A-759 as shown by the presented plat survey into 7 lots (lots 1-7). Builders Hugo Arce and Abisai Hernandez were present to answer questions. Dunn motioned to approve the replating as presented and was seconded by Pendleton.

2. Consider and approve suspending and delaying for no more than 45 days (forty-five) CenterPoint Energy's Statement of Intent to Increase Rates for the Texas Beaumont/East Texas Division effective date April 19, 2025. Pendleton motioned to approve suspending the rate increase and was seconded by Dunn.

3. Consider and the Certification of Unopposed Candidates as presented by Secretary Jordan. 3 (Three) candidates submitted packets for the 3 positions on the ballot creating an unopposed election. Pendleton motioned to approve the certificate of unopposed candidates and was seconded by Dunn.

**Motion Passed: 4-0**


