Discuss and take action regarding the TWDB 2020 project as it pertains to McKinney & Moore negotiations and project completion and take any action necessary. *\*This agenda item was on the November 10, 2025 meeting and passed with a 2-1 vote (quorum present). Due to general confusion in the conversation, it was assumed and announced that the motion failed and later motioned to table. For clarity of Council's decision, this agenda item has been placed back on the agenda for vote.\**
2. Consider and approve the 2025 Tax Roll as presented by Van Zandt County Appraisal District in the amount of \$700,423.93 and take any action necessary.
3. Consider and approve the Water/Sewer Fund to pay \$152,594.75 to the General Fund which is 50% of the total purchase price, \$305,189.50, for R000010553 consisting of 43.518 acres adjacent to the WWTP located on PR 7625 for future infrastructure improvements any action necessary.
4. Consider and approve a budget amendment to code 1016200 (G/F Police, Equipment Purchases) for the purchase of a 2026 Dodge Durango Pursuit vehicle at the cost of \$74,970.00 and take any action necessary.

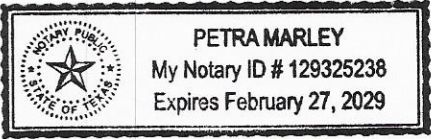
